VISAS FOR POLAND

Poland is a member of the European Union and a member of the Schengen Agreement. The visas are not required in the European Union's borders. There is no passport control at the borders for the whole territory of the Schengen Agreement.

ATTENTION

Every player, coach and accompanying person who need the visas are obliged to send by e-mail the copy of passports to the Championships Director till May 2, 2010.

Every player, coach and accompanying person have to register to the Championships Director.

Every player, coach and accompanying person are obliged to send by e-mail an identity photo 2x3 cm (electronic forms) for the badge.

FIDE FEES

Official Player: According to FIDE regulations the **70 €** entry fee is required for every player, except defending champions.

Additional Player: According to FIDE regulations the **140 €** entry fee is required for every player.

REGISTRATION FEES

Every player (including invited players), delegate, coach and accompanying person must pay to the Organizing Committee the amount of **100 €** Euro in advance.

BOARD & LODGING

Every basic player (see Regulations) is free of charge for accommodation (in double room) and board from dinner of August 2 to lunch of August 17, 2010.

If they wish to stay in a single room, they ought to pay 30 Euro per day (together 15 days - 450 Euro)

Every additional player, coach and accompanying person shall pay (hotel and board - three meals per day):

- stay in a **single room** (together 15 days - 1350 Euro) **90 Euro per day**
- stay in a **double room** (together 15 days - 900 Euro) **60 Euro per day**
- stay in a **room for three persons** (together 15 days - 825 Euro) **55 Euro per day**

Including entrance to swimming pool, sport hall and playground and other sport facilities.
